

## **OUTGOING WIRE TRANSFER REQUEST**

WIRE FRAUD ALERT – The following tips are recommended to minimize exposure to possible wire fraud:

- 1. **NEVER** rely solely on emails or other communications purporting to change wire instructions.
- 2. Do not forward wire instructions to other parties without verbally verifying the instructions from the sending party.
- 3. **ALWAYS** verify wire instructions, specifically the ABA number and account number, by CALLING the party who is receiving the funds.
- 4. **DO NOT** use phone numbers provided within the email containing the wiring instructions, use phone numbers you have used before or can otherwise verify. **DO NOT** send an email to verify as the email address may be incorrect or compromised by a fraudster.
